Learn to Skate: Program is suited for those kids who are just starting out and also for those who want to continue to progress to higher levels in their skating abilities.

- The cost is \$50/6 week session.

 - (Session III – Jan 7 – Feb 11) ****Feb. 4th there could be the possibility of no Parent/Tot that day and Synchronization will begin at 4:30pm, LTS 4-7 @ 5:30pm and 8 and older @6:30pm due to state tournament.**
 - (Session IV – Feb 18 – Mar 25) ****First Day of Class there will be no Parent/Tot that day and Synchronization will begin at 4:30pm, LTS 4-7 @ 5:30pm and 8 and older @6:30pm due to tournament.**

Waiver
